MAY IT PLEASE THE INDEPENDENT HEARINGS PANEL:

- 1. This memorandum of counsel for Christchurch City Council (**Council**) accompanies the rebuttal evidence filed on behalf of the Council.
- Counsel are grateful for the leave granted by the Independent Hearings
 Panel (Panel) on the terms set out in its Minute 15 dated 4 October 2023.
- 3. While leave was granted (as initially sought) to file rebuttal from over 40 Council witnesses addressing issues raised in almost 130 statements of evidence filed by submitters, on further review the scope of the Council's rebuttal has narrowed considerably. The 33 witnesses giving rebuttal evidence for the Council, and the submitter witnesses to whose evidence they respond, are listed in the **Appendix**.
- 4. As signalled in counsel's memorandum of 3 October 2023, it is not yet possible to file the rebuttal evidence of one Council witness, Mr Kleynbos, due to illness. Counsel will file that evidence as soon as possible.
