## MINUTE 15: RESPONSE TO APPLICATIONS FOR REBUTTAL EVIDENCE, AN APPLICATION BY CHRISTCHURCH CITY COUNCIL TO CROSS EXAMINE SUBMITTER EXPERT WITNESSES AND AN AMENDMENT TO HEARING PROCUEDURES REGARDING CROSS EXAMINATION

- [1] This is the fifteenth procedural Minute to be issued by the Independent Hearings Panel (IHP) established by the Christchurch City Council (the Council) to conduct the hearing of submissions on proposed Plan Change 14 Housing and Business Choice (PC 14) notified by the Council and to make recommendations to the Council, after the hearing of submissions is concluded, pursuant to Part 5, subpart 5A and Part 6 of Schedule 1, of the Resource Management Act 1991 (RMA).
- [2] The purpose of this Minute is to:
  - (a) acknowledge the receipt of applications seeking leave for the filing of rebuttal evidence, and to advise parties of the outcome of those applications.
  - (b) advise of the outcome of an application by the Council to cross examine submitter expert witnesses; and
  - (c) make an amendment to the directions for applications to cross examine expert witnesses to reduce the time for applications from ten working days to seven working days.

## Applications for leave to call rebuttal evidence

- [3] Applications requesting the leave of the Chair to file rebuttal evidence were received from the following parties within the timeframe<sup>1</sup>:
  - (a) Christchurch City Council<sup>2</sup>
  - (b) Christchurch International Airport Limited, submitter #852, #2052, #2105<sup>3</sup>
  - (c) Kāinga Ora Homes and Communities, submitter #834, #2082, #2099<sup>4</sup>
  - (d) KiwiRail Holdings Limited, submitter #829, #2055<sup>5</sup>

### Outcome

[4] Applications were considered and leave is granted for all applications for rebuttal evidence from Christchurch International Airport Limited, Kāinga Ora – Homes and Communities and KiwiRail Limited, as set out in Appendix 1.

- [5] The application for leave by Christchurch City Council is a global request pending further review by Counsel for the Council following receipt of all joint witness statements. Leave for the applications from Christchurch City Council for is granted on the assurance given by Counsel in paragraph 8 of their memorandum that all evidence will be reviewed to ensure that is focussed and in accordance with clause 8.4 of the Environment Court Practice Note.
- [6] We reserve the right to make further directions regarding the scope of matters addressed in Council and submitter rebuttal evidence once it has been received, should that be necessary for reasons of fairness to other parties.
- [7] All parties are required to abide by the timelines in the IHP's Hearing Procedures and rebuttal evidence is to be filed with the IHP Secretariat: <u>info@chch.2023.ihp.govt.nz</u> by noon on 9 October 2023. Rebuttal evidence will be filed on the IHP website as soon as practicable after receipt.
- [8] All parties are reminded to also serve the rebuttal evidence on the parties that it relates to.

#### Leave applications to cross examine submitter witnesses.

- [9] The Council has also filed a memorandum requesting 'global' approval for cross examination of all submitter witnesses pending clarification of the hearing schedule.<sup>6</sup> The Council requests 10 minutes per witness and Counsel propose to ask questions where they consider this will assist the IHP and submitters understand the outstanding issues that remain in contention between experts.
- [10] We acknowledge that finalisation of the hearing schedule, which identifies submitters and their witnesses is ongoing as the Secretariat work through the various requests for time by submitters and follow up on submitters who requested to be heard but have yet to confirm the timing of their attendance.
- [11] With that in mind, we grant the Council initial leave to cross examine expert witnesses called by any submitter that is to be heard from 11 to 19 October 2022 subject to giving that submitter notice of intention to do to the appropriate party. For cross examination of experts appearing from the week of 23 October 2023 the IHP would be assisted if the
