MINUTE 52: RESPONSE TO THIRD COUNCIL REQUEST FOR CLARIFICATION

Independent Hearings Panel – Plan Change 14 Housing and Business Choice

- [1] This is the fifty second (52) procedural Minute to be issued by the Independent Hearings Panel (the Panel) established by the Christchurch City Council (the Council) to conduct the hearing of submissions on proposed Plan Change 14 Housing and Business Choice (PC 14) notified by the Council and to make recommendations to the Council, after the hearing of submissions is concluded, pursuant to Part 5, subpart 5A and Part 6 of Schedule 1, of the Resource Management Act 1991 (RMA).
- [2] The purpose of this Minute is to respond to the Memorandum of Counsel for Christchurch City Council filed at the end of the day on 19 August 2024 (the third memorandum)¹ requesting the Panel clarify how it is has interpreted and applied the High Court decision in *Kāpiti Coast District Council v Waikanae Land Company Limited* [2024] NZHC 1654 (Waikanae).²
- [3] Under the RMA, Schedule 1, clause 101(4)(c) the Council may seek clarification from the independent hearings panel on a recommendation in order to assist the specified territorial authority to make a decision.

Council Request

- [4] The Council seeks, in its third memorandum, further clarification to assist in reconciling the Panel's recommendations. In particular, the Council asks the Panel to:³
 - (a) advise whether the Council has correctly understood the recommendations in respect of these matters (as summarised in this memorandum);
 - (b) clarify how it has interpreted and applied *Waikanae*, supplementing (to the extent necessary) the analysis of that recommendation in its Recommendation Reports;
 - (c) confirm whether any changes to the Panel's recommendations are necessary; and
 - (d) provide the details of any legal opinion(s) or submission(s) the Panel has relied upon to support its analysis of and approach to *Waikanae*, in addition to those referred to in paragraphs [176] and [178] of Part 1 of its Recommendations Report (**Part 1**).
- [5] In seeking these clarifications, the Council has advised that it is conscious that the Panel⁴:

- (a) has set out its key findings in respect of *Waikanae* in paragraphs [155] to [183] of Part 1 and in paragraphs [59] and [60] of Part 4 of its Recommendations Report (**Part 4**); and
- (b) has already provided clarifications regarding the redrafting of Chapter 14 of the District Plan in its minute 50, which exercise has brought to light the additional matters on which clarification is now sought.
- [6] Counsel has also advised that it is mindful that the Panel has not invited further legal argument from the Council or submitters in respect of *Waikanae*, for the reasons given at paragraph [158] of Part 1 of the Recommendations Report.

Panel Response

Advise whether the Council has correctly understood the recommendations in respect of these matters (as summarised in this memorandum)

- [7] In respect to Paragraphs 19-27 of the third memorandum the Council has correctly summarised aspects of the Panel's approach to our recommendations, particularly at Paragraph 26. The Panel also refers the Council to Part 1 paragraphs [154] [183] in full and in particular to [156], [157] and [181].
- [8] However, the Council appears to have interpreted the Panel's three pathway approach which recommends that pathway A retain the 'status quo' in its entirety, as having been arrived at simply by extrapolating the factual circumstances of the High Court decision of *Waikanae*, rather than the Panel's interpretation of s80E of the Act. The Panel has interpreted s80E in light of its text and purpose, and as we interpret the *Waikanae* decisions, so too did the Environment Court and the High Court. We refer the Council to Part 1 of the Recommendations Report at [156]. We have simply applied the law to the facts in front of us.
- [9] In Part 1 and Part 4 of our Recommendations Report, in particular Part 1 [173] and Part 4 [61] [64], the Panel, recommends the three pathway approach to separate out status quo enablement's entirely, because as we have said, we found ourselves unable to unpack or unpick Chapter 14 to account for the proper interpretation and application of s80E. The Panel landed on the three pathway approach as the simplest and most pragmatic work around given the timing available.

Clarify how it has interpreted and applied *Waikanae*, supplementing (to the extent necessary) the analysis of that recommendation in its Recommendation Reports

[10] The Panel has already set out how it has interpreted and applied s80E and 80G of the Act, including how both the Environment Court and High Court interpreted s80E in Waikanae in Part 1 of the Recommendations Report at paragraphs [155] – [183]. The Council appears to be inviting the Panel to reconsider aspects of its interpretation in a way that appears beyond the bounds of a 'clarification'. We do not consider this is necessary or appropriate, given our reasons were reached having considered the views of a range of submitters, who do not have standing in this 'clarifications' aspect of the ISPP process.

Confirm whether any changes to the Panel's recommendations are necessary

- [11] It is not clear if the Council's query relates to the Recommendation Report reasoning or the recommendations themselves. The Panel confirms no changes are necessary to the Recommendations Report reasoning nor in response to the specific 'recommendations' referenced in the Council's third memorandum on the basis of the issues the Council has raised in the third memorandum in paragraph 37. The Council has signalled the prospect of a further memorandum seeking other clarifications. We respectfully request that the Council to collate its remaining questions of clarification and file these in one go, rather than on a piecemeal basis, both in the interests of efficiency and to ensure that the Panel has the opportunity to consider the context of the clarifications being sought.
- [12] Once the Panel has received the further memorandum we will consider if any further clarifications or corrections are necessary, as we have done in Minutes 50 and 51.

Provide the details of any legal opinion(s) or submission(s) the Panel has relied upon to support its analysis of and approach to *Waikanae*, in addition to those referred to in paragraphs [176] and [178] of Part 1 of its Recommendations Report (Part 1).

[13] The Panel refers the Council to Part 1 of the Recommendations Report at [154] – [181], in particular to [154], [156] and at [174] and [175] and the associated footnotes. Further all the legal opinion(s) or submission(s) are available on the Panel's website⁵, and a recording of the hearings is also available on the Panel's website. For the avoidance of doubt, the Panel has not obtained any other 'legal opinions' on the interpretation of s80E or the *Waikanae* decisions outside of the hearing process and has relied on the materials

and references provided to the Panel during the hearings by submitters, their legal counsel and the Council's legal counsel, and we interpreted the legislation having considered the range of views expressed.

[14] The Panel does not agree that further clarification is required or is necessary to support the Panel's interpretation of s80E of the Act beyond that set out in [154] - [183] of Part 1 of the Recommendations Report. To the extent the Council may find it useful as part of its decision making to review for itself the range of written legal submissions and the oral presentations of those submissions that were available to the Panel, the Panel has attached a list of legal submissions and links to the presentations that the Panel found useful to assist in our interpretation of s80E of the Act.
