- [1] This is the sixth procedural Minute to be issued by the Independent Hearings Panel (IHP) established by the Christchurch City Council (the Council) to conduct the hearing of submissions on proposed Plan Change 14 Housing and Business Choice (PC 14) notified by the Council and to make recommendations to the Council, after the hearing of submissions is concluded, pursuant to Part 5, subpart 5A and Part 6 of Schedule 1, of the Resource Management Act 1991 (RMA).
- [2] The purpose of this Minute is to advise all parties of amendments to the hearing timeline issued by the IHP on 15 August 2023.
- [3] On 18 August 2023 legal counsel on behalf of Carter Group Limited ¹ and Kāinga Ora Homes and Communities² filed a memorandum of counsel seeking amendments to the hearing timeline.
- [4] The IHP agrees to the proposed amendments, with the exception of the date proposed for the filing of legal submissions, which remains at five working days before the submitter's allocated speaking time.
- [5] The IHP also updates the timeline to require that evidence and documentation is required to be filed by 12 noon on the day it is due.
- [6] These amendments to the hearing timeline are detailed in Appendix 1 to this Minute which will be published on the IHP website³.
- [7] The IHP's Hearing Procedures, available on the IHP website will be updated to reflect the changes detailed in this Minute.
- [8] Submitters are encouraged to file expert evidence in chief and other documentation in advance of the due date wherever possible.
- [9] The IHP reminds all parties that if evidence is not filed with the IHP Secretariat by 12noon on the day it is due then that party must ensure that evidence is pre-circulated to the Council and every other submitter to be heard on that hearing topic by alternative means.⁴
