INSTRUCTIONS AND EXPLANATIONS

Changes recommended by the Independent Hearings Panel

The changes recommended by the Independent Hearings Panel are based on Council's 'Reply Provisions' version, which include:

- Text recommended to be added/deleted by proposed PC14
- Text recommended to be added/deleted within s42A reports
- Text recommended to be added/deleted from expert conferencing/joint witness statements
- Text recommended to be added/deleted within s42A reports in response to matters raised during Hearings

Where the Independent Hearings Panel recommends that the proposed PC14 provision text be accepted or added to, the text is changed to **bold underlined**, and for text to be deleted to **bold strikethrough**

Where the Independent Hearings Panel recommends that green definitions or the blue links to other provisions and/or external documents are accepted they *remain* unchanged.

Changes recommended by the Independent Hearings Panel (including to proposed PC14 provisions, definitions and links as described above) are shown as **bold underlined** for text in the Council's 'Reply Provisions' that are recommended to be accepted or for additional new text, and **bold deleted** for text to be deleted (i.e. the purple and orange colours in the Council's 'Reply Provisions' have been removed).

FURTHER INSTRUCTIONS AND EXPLANATIONS FOR COUNCIL

Where practical, the Panel has updated the provisions in each Chapter in accordance with the approach set out above.

It is noted that in undertaking the <u>bold underlined</u> and <u>bold deleted</u> exercise, the green colour for definitions and the <u>blue</u> colour for links has been overwritten. It will be necessary for Council to correct these as they update the provisions.

While every attempt has been made to update the numbering, in some instances this has not been undertaken due to formatting issues. It will be necessary for Council to update the numbering as they update the provisions.

Updating or deletion of diagrams and other provisions that are in pdf format have not been updated. Panel instructions have been included.

There are some recommendations from the Panel that are not able to be shown, either because the recommendation is broad or requires Council to undertake additional work. Examples include:

- Revert to the Operative District Plan version of the chapter;
- Residential Hills zone is recommended to be retained for areas subject to Outline
 Development Plans, with the remainder of the zone to be rezoned to MRZ and a new
 qualifying matter to be developed;
- Updating of zone names to reflect the Panel zoning recommendations;
- Consequential changes resulting from other recommendations.

Where the Panel recommendation is to return parts or the whole of the chapter to the Operative District Plan version, Panel instructions have been included.

Where there are 'broad' or 'additional work' further instructions, the Panel instructions set out at the beginning of each Chapter.

Where there are <u>detailed instructions</u>, these are set out at both the beginning of each Chapter and against the relevant provision within the Chapter.

Where there are <u>explanations</u> as to how the Chapter has been amended, these are set out at both the beginning of each Chapter and against the relevant provision within the Chapter. Examples include:

Objective 3.3.7 – *Urban growth, form and design* is recommended to be deleted and revert to the Operative District Plan version subject to consequential changes (such as zone names).
